From 2019 an additional category of Associate Member has been introduced. Associate Membership encompasses any company or industry organisation that participates in or has an interest in the lighting industry in New Zealand. This new category reflects the rapidly changing nature of lighting in the global context where digitalisation, connectivity, internet of things and smart houses, buildings, infrastructure have revolutionised the world of lighting.

Overview of Lighting Council New Zealand Activities

LCNZ continues to work on a broad range of issues affecting the lighting industry and consumers, as well as international trade, energy and the environment:

PROMOTION OF EFFECTIVE LIGHTING

Production of communications and guidance to assist with demystifying market trends, technical standards and regulatory requirements.

GOVERNMENT RELATIONS

A cohesive industry voice to government on matters of lighting energy, safety, radio interference, environment and local and international trade.

NZS AND AS/NZS TECHNICAL STANDARDS

Substantial financial, intellectual and experiential investment in local lighting standards development.

INTERNATIONAL ELECTROTECHNICAL COMMISSION (IEC) STANDARDS

Substantial direct participation in international IEC lighting safety and performance standards development.

GLOBAL LIGHTING ASSOCIATION (GLA)

Direct participation at the global level in analysis of market impacts of new technologies and proposed standards and regulations.

NON-COMPLIANT PRODUCT WATCH

Active market monitoring and regulatory surveillance for non-compliant lighting products.

MISLEADING ADVERTISING WATCH

Active market monitoring of media advertising messages about lighting performance and energy efficiency.
